First-aid measures general

4.2. Most important symptoms and effects, both acute and delayed

Symptoms/effects : Causes severe skin burns and eye damage.
Symptoms/effects after inhalation : May cause respiratory irritation.
Symptoms/effects after skin contact : Highly corrosive to skin. Cracking of the skin. Causes severe burns.
Symptoms/effects after eye contact : Causes serious eye damage. Causes serious eye irritation. redness, itching, tears.
Symptoms/effects after ingestion : May be harmful if swallowed. Burns or irritation of the linings of the mouth, throat, and gastrointestinal tract. Burns to the gastric/intestinal mucosa. Harmful if swallowed. Ingestion may cause nausea and vomiting. Blood in vomit.

Treat symptomatically.

SECTION 5: Firefighting measures

5.1. Extinguishing media

Suitable extinguishing media : Dry chemical, CO₂, or water spray or regular foam. Water spray.

5.2. Special hazards arising from the substance or mixture

Hazardous decomposition products in case of fire : Corrosive vapours. Toxic fumes may be released.

5.3. Advice for firefighters

Firefighting instructions : Do not enter fire area without proper protective equipment, including respiratory protection. Exercise caution when fighting any chemical fire. Prevent fire fighting water from entering the environment. Use water spray or fog for cooling exposed containers.

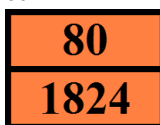
